**3.1 Constitution**

**10th PCM:**

The National Secretariat wrote to Maha FORCES regarding the decision of the PCM to participate in WSF and to request them to host the PCM at Mumbai in January 2004. Dr. Vrinda Dutta agreed in principle but needs more time to find out about logistics ( accommodation for 50 persons ) on the TISS campus and will inform accordingly.

**Training workshop on Budget analysis**

It was informed at OCity that Disha ( Ahmedabad ) was organising a training workshop on the subject and five names were received from the floor which was communicated to Chetna Kotecha. However, only Chetna could attend this training workshop at Delhi on 27-28 June 2003. Those who did not inform/attend were Karnataka FORCES, Delhi FORCES, Uttar Pradesh and Tamil Nadu FORCES. Awadhesh who was also to attend the training could not due to being away from Delhi for personal reasons.
